

WHEREAS the **TEHATTA SADANANDA MAHAVIDYALAYA**, with a view to achieve academic excellence desirous to exchange various fields of the institutions, proposed **GOVERNMENT GENERAL DEGREE COLLEGE**, **KALNA-I** to collaborate and GOVERNMENT GENERAL DEGREE COLLEGE, KALNA-I, as the Second Party, accepted the proposal of the First Party.

NOW THIS MEMORANDUM OF UNDERSTANDING is agreed by and between both the Colleges hereto as follows:

- 1. Both institutes, Tehatta Sadananda Mahavidyalaya and Government General Degree College, Kalna-I hereby, agree to encourage and establish a partnership between the two institutions with the objective of promoting academic collaboration and exchange of knowledge and resources between the two institutions in furtherance of the advancement of learning as stated below:

- 5. Both the Parties mutually agreed not to include any financial transaction during the execution of this MOU.

This Memorandum of Understanding is valid for five (5) years, and both institutes consent to review and evaluate this Memorandum of Understanding after five (5) years following the date of signing, and acknowledge that this Memorandum is subject to revision and termination at any time by mutual consent or by six (6) months' written notice by either institute. 
