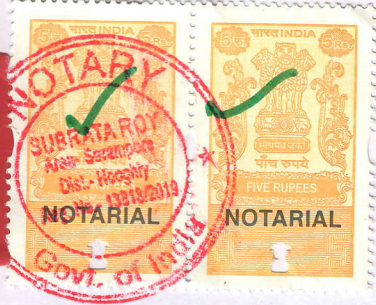

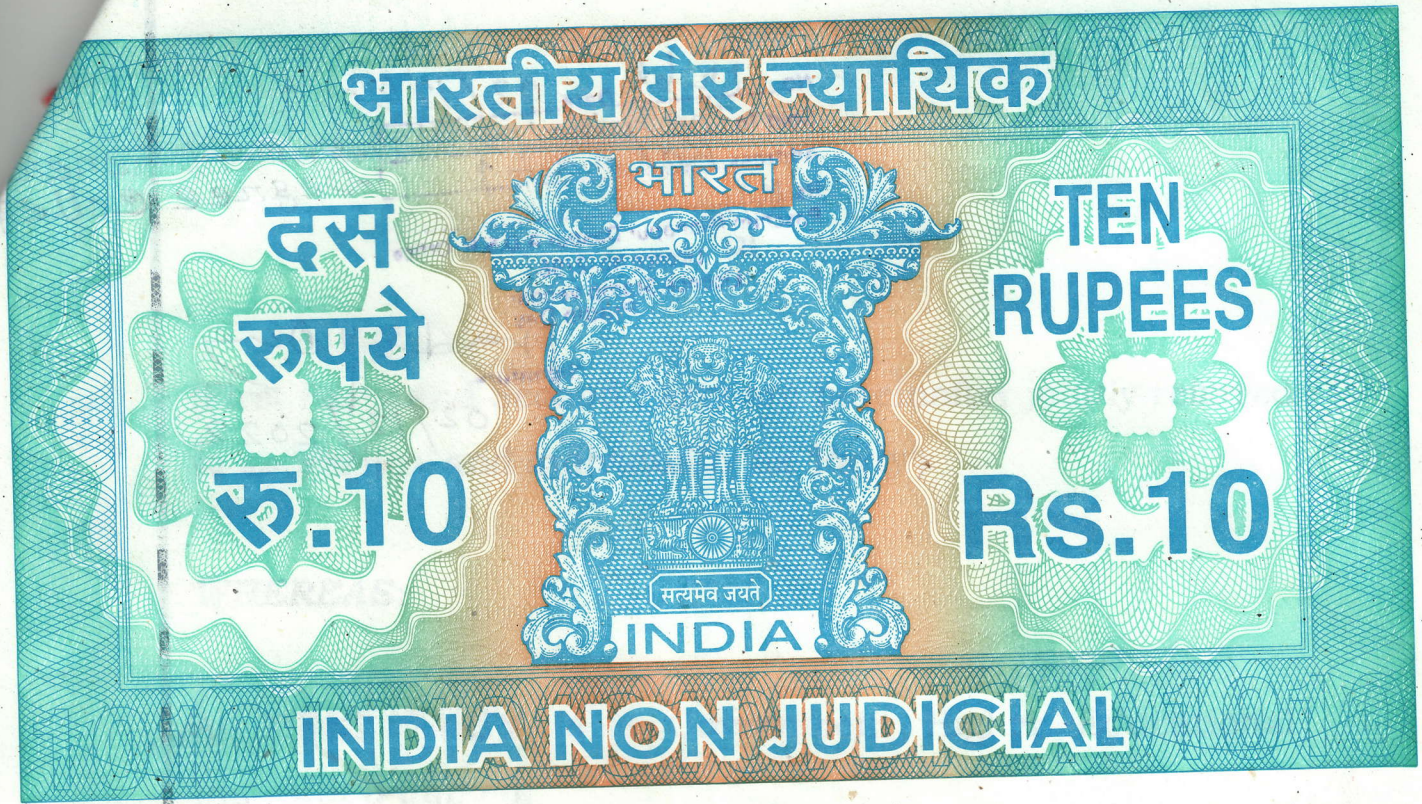

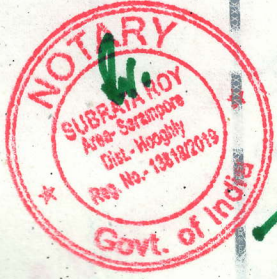

✓ A) FIRST PARTY is a Government Higher Educational Institution named:

✓ B) First Party and Second Party believe that collaboration and cooperation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.

✓ C) The parties intent to cooperate and focus their efforts in cooperation within the area of sharing social responsibility, community awareness generation, healthcare support and to facilitate advancement of knowledge on the basis of reciprocity, best effort, mutual benefit, and frequent interactions.

✓ D) Both Parties being legal entities in themselves desire to sign this MOU for advancing their mutual interests.

✓ E) KALNA SUB DIVISIONAL AND SUPER SPECIALITY HOSPITAL, Kalna-Katwa Road, Kalna Purba Bardhaman-713409, the Second Party is a sub-divisional government hospital in the state of West Bengal under the aegis of the

Department of Health & Family Welfare, Government of West Bengal and is engaged in imparting healthcare services at present with rights, possibility and extension thereafter.

F) The Second Party presently functions from its own campus at Kalna-Katwa Road, Kalna Purba Bardhaman, West Bengal and will continue to do so until further order from the Competent Authority. It has no other branch, wing, subsidiaries or extensions existing at present.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISE SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

Clause-I
CO-OPERATION

1.1 Both the Parties are united by common interest and objectives, and they shall establish channels of communication and co-operation that will promote and advance – awareness, screening, diagnosis and in few cases treatment and management with follow up may from hospital end.

1. General health check-up camp may arrange from Hospital end at least once in a year.

2. Voluntary blood donation motivational session cum camp may arrange twice in a year.

3. Thalassemia/ haemophilia/ Sickle Cell anaemia / HIV /Hepatitis- B /Hepatitis -C /Tuberculosis etc. awareness cum screening session may arrange at least twice in a year.

4. Observance Save Earth and Environment through arrangement of World Environment Day on 5th June and Earth day on 22 April by some effective campaign to raise awareness among the students.

5. For promotion of hygiene and sanitation, the Hospital authority will arrange a session on cleanliness drive where participation of college students in batch wise at hospital premises as evidence of coordination.

6. Mental health counselling may arrange time to time from hospital end.

7. Involving students in community based and promotional activities; and

8. Any other joint venture for academic enrichment of both the colleges on prior agreement of the Principals and Superintendent of the concerned institutions; within the Institution and its related wings.

1.2 Both the Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

1.3 First Party and Second Party must respect each other's to intellectual property and the disputes if any, relating to

any aspect of mutual cooperation, Head of the Institution of both the Organization will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.

1.5 Both the Parties mutually agreed not to include any financial transaction during the execution of this MOU.

1.6 Neither Party shall be held responsible for non-fulfillment of their respective obligation under this MOU due to circumstances beyond their control but not limited to pandemic, war, flood etc. If such condition continues beyond six months, the parties shall then mutually decide about the future course of action.

1.7 Nothing in this MOU shall be constructed to make either party a partner, an agent or legal representative of the other for any purpose. Now onwards both the party may mention the name and LOGO of the other in their documents as "COLLABORATOR" for purpose as may be required subject to communication by the user to the other party in writing beforehand.

1.8 This MOU unless terminated by mutual written agreement will continue for 5 years after the effective date specified in the opening paragraph and can be renewed through mutual interest. Either Party shall have the right to unilaterally terminate this MOU upon 90 days prior written notice to the other party.
